EXAMPLE AND CONTRACT OF CHILDREN

Read label before use. Keep container tightly closed. Keep only in original container. Avoid breathing dust, fume, gas, mist, vapors, spray. Wash contaminated areas thoroughly after handling. Do not eat, drink or smoke when using this product. Wear protective gloves, protective clothing, eve protection, face protection.

FIRST AID

IF IN EYES: Rinse cautiously with water for several minutes. Remove contact lenses if present and easy to do then continue rinsing.

IF SWALLOWED: Unless advised otherwise by a poison control center or doctor, have person rinse mouth with water, if able. Do not give anything by mouth to an unconscious person.

IF INHALED: Remove victim to fresh air and keep at rest in a position comfortable for breathing. If person is not breathing, call 911 or an ambulance, and then give artificial respiration, preferably mouth to mouth if possible.

GENERAL INFORMATION

CHS TRAPLINETH PRO is a patent pending surfactant emulsion technology that significantly improves uniform coverage and adhesion of the active ingredient on the target surface.

CHS TRAPLINE PRO helps to limit the formation of driftable fines and manages droplet formation within the optimum size range without pump shear during application.

CHS TRAPLINE PRO sequesters and chelates hard water ions to prevent adverse interactions with active ingredients that may occur when the carrier water is of unknown quality.

CHS TRAPLINE PRO is recommended for all crops and non-crops and is compatible with most active ingredients.

DIRECTIONS FOR USE

Always follow the directions on the most restrictive active ingredient label.

Tank mixtures should only be applied within the label recommendations of every product in the tank mixture.

Use only if a nonionic surfactant (NIS), water conditioner, drift reduction technology (DRT), and deposition agent are allowed or not excluded on the label.

CHS TRAPLINE PRO does NOT contain ammonium sulfate (AMS).

NOTE: When combining new or unfamiliar components in any tank mix, the applicator should conduct phytotoxicity and jar tests to ensure compatibility and avoid damage to non-targeted species.

Order of addition

In general, follow the W-A-L-E-S plan when adding herbicides to a tank mix.

- 1. Wettable Powders (WP) then Flowables (F, DF)
- 2. Agitate then add anti-foaming compounds, buffers
- 3. Liquid and Soluble products
- 4. Emulsifiable concentrates (EC)
- 5. CHS TRAPLINE PRO and other adjuvants

Prior to mixing, fill the spray tank with half of the carrier. Start the sprayer and check to make sure that all valves and gauges work and that there is adequate tank agitation.

USE RATE

The optimal rate of CHS TRAPLINE PRO® may vary with environmental conditions and spray water quality. As field and application conditions change, an experienced operator should adjust the rates as needed.

STORAGE AND DISPOSAL

Storage: Sediment may be observed. Shake well with water and add to tank mix when appropriate. Store in a cool well-ventilated place. Keep in original container tightly closed. Do not reuse empty container. Do not store with food, feed, or other material to be used or consumed by humans or animals. Do not contaminate water supplies. For optimal product quality, store between 40° and 90° F. SHAKE WELL BEFORE USING.

Disposal: Do not contaminate water, food or feed by storage or disposal. Dispose of contents in container to an approved waste disposal facility in accordance with all local, regional, national, international regulations. Triple rinse (or equivalent) adding rinse water to application tank. Offer container for recycling or dispose of in a sanitary landfill or by other procedures approved by local regulations.
