General Information

CHS WHEELHOUSE PRO is a water conditioning agent formulated to enhance pesticide performance by modifying the hardness of spray water. CHS WHEELHOUSE PRO imparts a neutral pH. CHS WHEELHOUSE PRO can reduce antagonism of the spray tank caused by hard water minerals such as calcium, iron & magnesium. CHS WHEELHOUSE PRO improves spray droplet spreading, deposition and penetration into the targeted leaf surface. CHS WHEELHOUSE PRO provides humectancy to spray droplets resulting in a slower drying time for enhanced uptake of active ingredients. CHS WHEELHOUSE PRO can be used for a wide range of pesticide & nutrient spray mixtures when accompanying labels recommend water conditioners and spreader-wetter adjuvants.

First Aid

Call a poison control center or doctor immediately for treatment advice. Have the product container or label with you when calling a poison control center or doctor, or going for treatment.

IF IN EYES: Rinse continuously with water for several minutes. Remove contact lenses if present and easy to do; continue rinsing. If eye irritation persists, get medical attention.

IF INHALED: Move person to fresh air and keep at rest in a position comfortable for breathing. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably mouth-to-mouth if possible. If you feel unwell, call a poison control center or physician for further treatment advice.

IF ON SKIN OR CLOTHING: Rinse skin immediately with plenty of soap and water for 15 to 20 minutes. If skin irritation occurs, get medical attention. Take off contaminated clothing and wash before reuse.

Directions For Use

For use with herbicides registered for use for agriculture, forestry, industrial, municipal, ornamental, turf, right-of-way, non-cropland, and other uses. Prior to using **CHS WHEELHOUSE PRO**, the user must have experience with the combination of active ingredients or must have conducted a phytotoxicity trial.

Use Rates

CHS WHEELHOUSE PRO may be applied by ground, CDA or aerial spray equipment.

Ground/Aerial: Use 1 to 4 quarts per 100 gallons of spray mixture (0.25% v/v to 1.0% v/v). Do not use this product at a rate to exceed 2.5% v/v of finished spray tank mixture.

200-400	2 quarts
400-600	3 quarts

Tank Mixing

Prior to any pesticide application, all spray equipment must be thoroughly cleaned. Carefully observe all tank cleaning directions on the pesticide label. Follow the mixing order on the pesticide label.

If the mixing order is not clear, follow the following mixing instructions: 1) Fill the spray tank 1/2 full with water; 2) Add any dry formulations to the spray tank and allow to disperse completely into solution; 3) Continue to add other pesticides and ingredients, including CHS WHEELHOUSE PRO, consistent with respective label directions. It is preferable, but not required, to add CHS WHEELHOUSE PRO prior to adding the glyphosate herbicide. Do not mix CHS WHEELHOUSE PRO with undiluted herbicides.
