FIRST AID

FOAM MARK is a tough, flexible foam marker intended to tolerate a broad variety of conditions including adverse weather conditions. FOAM MARK includes components that allow the product to perform in practically any water, hard, soft, hot or cold. FOAM MARK will make a firm, dense foam with outstanding stability.

DIRECTIONS FOR USE

Mix FOAM MARK with water and place in foam marker tank.

Use about 1 gallon of FOAM MARK for every 100 gallons of water. If foam is runny or watery, put in additional FOAM MARK until preferred texture and stability are attained. If foam is too thick, add water.

HANDLING AND STORAGE

Store in a cool well-ventilated place. Keep in original container tightly closed. Do not reuse empty container. Do not store with food, feed, or other material to be used or consumed by humans or animals. Do not contaminate water supplies.

CONTAINER DISPOSAL

Do not contaminate water, food or feed by storage or disposal. Dispose of contents in container to an approved waste disposal facility in accordance with all local /regional/national/international regulations. Triple rinse (or equivalent) adding rinse water to application tank. Offer container for recycling or dispose of in a sanitary landfill or by other procedures approved by local regulations.
