The addition of nitrogen based fertilizers (such as 28% N, or 10-34-0), or ammonium sulfate, are generally not required with LINKAGE*. Follow herbicide label directions.

Use LINKAGE at 0.5 - 1% v/v (2 - 4 quarts per 100 gal spray mixture).

For water volumes below 5 gpa, use 1 - 2% v/v (1 - 2 gal per 100 gal spray mixture).

Add LINKAGE last to spray mixture and continue agitation, or follow specific tank filling and mixing information provided on the herbicide label. Refer to the herbicide label for additional recommendations or precautions.
