combination of improved spreading and uptake, provided by the surfactant, and reduction of hard water interaction and enhanced uptake, provided by the ammonium sulfate.

Precinct $^{\text{TM}2}$ is recommended for use on all crop and non-crop sites.

Use Precinct² at a rate of 3 to 10 quarts per 100 gallons of tank mix. Add according to the directions on the pesticide label. If no directions are given, use the table below as a general guide. Weed type, weed height, environmental conditions and other factors can impact use rate needed. Do not premix with concentrated oil or lecithin products. Add each product separately.
