### GENERAL INFORMATION

Soyshot® is a starter fertilizer with a low salt index developed for maximum crop safety and performance specifically designed for use in soybeans as an in-furrow starter fertilizer.

### DIRECTIONS FOR USE

General guidelines: A number of variables influence the rate of application necessary to control or correct a specific deficiency. For best results, follow good agronomic practices, soil test and if necessary, use tissue analysis. User should also seek the advice of a certified crop advisor or trained agronomist. For specific crop recommendations in your area, consult your states recommendations.

### APPLICATION DIRECTIONS

For use as an in-furrow Starter fertilizer: Apply 1-2 gal/A of Soyshot alone or with water as an in-furrow starter fertilizer in soybeans.

### FIRST AID

**IF SWALLOWED:** Rinse mouth. DO NOT induce vomiting
